#### **CONDITIONS OF SALE**

1. The Commission reserves the right to accept or reject and annul the process at any time prior, without thereby incurring any liability to bidders. In case of annulment, all bidders submitted, and specifically, the deposit, shall be promptly returned to the bidders
2. Interested bidders are required to pay a refundable deposit of **10% of the reserve price for each lot/item** they are interested in. This will be the basis of obtaining the bidding number before the auction date.
3. The refundable deposit shall be deposited in the NPSC Account detailed below;

6. Upon paying the Interested bidders will be required to present their Bank deposit Slips to the NPSC Accounts Office located on 6<sup>th</sup> Floor, CBK Pension towers, during normal office working hours (8.00 am to 5.00pm) and will thereafter be issued with a MR receipt.
7. The issued MR receipt shall be used to obtain the Bidding Number from procurement office at CBK Pension tower, 6<sup>th</sup> floor.
8. **No Bidding whatsoever** shall be allowed for a bidder without the Bidding Number.
9. The deposit will be treated as part payment for the successful bidders.
10. The Items/Asset are sold on 'as is where is basis' and are subject to a reasonable reserve price.
11. The successful bidder **MUST** pay a deposit of 40% of the purchase price by the fall of the hammer.

12. The successful bidders in the public auction shall be given a period of at least seven days from the date of the auction to pay for the items. The purchased Item/ Asset must be collected within seven (7) days after making payment, failure to which the purchaser shall be liable to pay storage charges of **Ksh. 1,000 (Kenya Shillings One Thousand)** per day.
13. Where the successful bidder fails to meet the requirements in paragraph 12 above, the bidder shall forfeit the bid deposit.
14. The successful bidders shall pay all costs, applicable duties, and taxes assorted with the transfer of the purchased Item/ Asset i.e., motor vehicle.
